The Merchant Fair Trading Group have now published the Merchant Fair-Trading Guidelines in the Qoin App, these guidelines have been designed to protect both merchants and consumers from misleading or deceptive trading behavior and unfair practices. We expect all Merchants to follow these guidelines when they sell their goods and/or services using Qoin as part of this process.

If you find a merchant trading unfairly or isn't accepting Qoin despite showing up in the Directory, we encourage you to report this merchant through the Qoin app, and this will be looked into.

Our next step is to publish a video which will outline these guidelines, our intention is to get all Merchants to watch this Merchant Fair Trading Video, then at the end of the video agree to trade within these guidelines at all times, and in turn that merchant will receive a Fair-Trading Badge on their listing. This will in turn give other merchants and consumers the confidence to trade in Qoin with these merchants.

Our group has also been working with others looking into splitting the Q Shop to become a separate Directory and Trading Platform, we look forward to working on this project over the next quarter.

Some Australian banks have blocked their customers trading with crypto exchanges and also closing exchanges bank accounts, this all impacts people's own financial freedoms. In the USA the two largest crypto exchanges, Coinbase and Binance, had actions brought against them by the SEC. This certainly creates uncertainty for the mainstream public. This next quarter will be a defining period with crypto in Australia, as adoption continues within the space. Will the major Fund Managers Globally create some stability? Only time will tell.
